## 43<sup>th</sup> Rechtshistorikertag, September 7-11, 2020 in Zurich

Dear colleague,

The developing COVID-19 crisis makes it unlikely that the ,Rechtshistorikertag' (the Middle-European Legal History Conference) can go ahead as planned this September in Zurich. Switching to an online-based conference seemed to us also, for various reasons, not a viable option.

We have therefore decided to cancel the 2020 Zurich 'Rechtshistorikertag'. After consultation with the Standing Committee, we intend to hold the conference in 2022 instead.

Due to logistical restraints, we had to choose a slightly earlier date in the summer: We look forward to welcoming you in Zurich from August 8-12, 2022.

The 2022 'Rechtshistorikertag' shall be devoted to the 'Forms of Validity of the Law' ('Geltungsformen des Rechts'), just as announced for 2020 and, as far as possible, will feature the same plenary papers and sections.
